Requests for searches of death records through the IDPH may be made for a fee of \$10.00 per name, if a record is found and is more than 20 years old, one uncertified copy would be issued without additional charge.

**MARRIAGE:** Illinois State Archives has a database of more than one million marriages for the years 1763 to 1900, copies may be obtained from Illinois Regional Area Depository system ([cyberdriveillinois.com/departments/archives/irad/famtips.html](http://cyberdriveillinois.com/departments/archives/irad/famtips.html) ). IDPH has a statewide index of marriages from 1962 through the current index date, for a \$5 fee it can verify the facts of a marriage or perform a search if you do not know the County where the marriage occurred.
